



## Conditions of Entry – Happiness in the Holidays Competition

Information on how to enter the **Happiness in the Holidays** (Promotion) and prizes form part of these Conditions of Entry. Entry into the Promotion is deemed acceptance of these Conditions of Entry. Entry is via the entry form on [darlingharbour.com](http://darlingharbour.com) only.
3. Entry is only open to residents of Australia aged 18 years or older (inclusive).
