



## Conditions of Entry – Christmas Competition

---

1. The Promoter is Place Management NSW of Level 2, 66 Harrington Street, The Rocks, NSW 2000. A.B.N.51 437 725 177 2, Phone number (02) 9240 8500. Information on how to enter the **Christmas Competition** (Promotion) and prizes form part of these Conditions of Entry. Entry into the Promotion is deemed acceptance of these Conditions of Entry. Entry is via the entry form on [darlingharbour.com](http://darlingharbour.com) only.
3. Entry is only open to residents of Australia aged 18 years or older (inclusive). (Eligible Entrants).
